Cut-Down Bundles

If cut-downs into shorter time formats are requested alongside an order, the client will not be charged for each cut-down individually but rather charged an hourly rate of \$90/hr (1hr minimum) for the creation of cut-downs.

Tier 3 Cool Down Period

Stonebed offers a courtesy 90-day cool down period before making sound assets composed for Tier 3 (Premier) projects available on the Stonebed Music Library. The client may request to extend this period at a rate of \$350 pm.

Retainers

Stonebed offers a custom, discounted solution for retainers of 6 months or longer. This applies to composition / music placement services only.

Mixing and Mastering

Where the mixing and mastering of additional elements against the scoring component needs to be incorporated by Stonebed, the client will be charged an hourly rate of \$90/hr (1hr minimum) for this service. Additional elements include (but are not limited to) voice-overs and requested session recordings of external service providers*.

Disclaimers

Fairness Policy regarding revisions

Stonebed employs a Fairness Policy regarding revisions. This means that revising work to fix issues after delivery will be completed where reasonable. However, where desired revisions require the creation of an entirely new version of the track, the client will be billed an hourly rate of \$90/hr (1hr minimum). Clear and detailed briefs are thus essential to avoid unwanted costs and time delays.

*Special requests for external service providers

If the client requires Stonebed to make use of specific external service providers for a project, these will be included at the cost of the client. External service providers include (but are not limited to) voice-over artists, session musicians and other performing artists.
